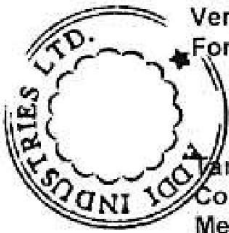

Trump says Putin has 'gone crazy' after Russia drops attack on Ukraine

Russia overnight launched the biggest drone attack on Ukraine in the more than three-year war, a Ukrainian official said Monday. US President Donald Trump said Russian leader Vladimir Putin has gone "crazy" by stepping up the bombing of Ukraine while the US tries to broker peace.

The Russian bombardment on Sunday night included 355 drones, Yuriy Ihnat, head of the Ukrainian air force's communications department, told media. Russia also fired nine cruise missiles during the attack, Ukrainian authorities said. Officials reported some civilians were injured. No deaths were immediately reported.

On Saturday night, the Ukrainian capital Kyiv and other regions came under a massive Russian combined drone-and-missile attack that killed at least 12 people and injured dozens, Ukrainian officials described that bombardment as Russia's largest aerial assault during the conflict, using 69 missiles of various types and 298 drones. The numbers could not be independently verified, and there was no immediate comment from Russian authorities. The US, backed by European leaders, has pushed to stop the fighting, but without making a breakthrough. Efforts to broker a ceasefire and engage both sides in efforts to reach a peaceful settlement have shown few results. Trump made it clear he is losing patience with Putin. "He always had a very good relationship with Vladimir Putin of Russia, but something has happened to him. He has gone absolutely CRAZY!" Trump wrote in a social media post on Sunday night.

Trump said Putin is "needlessly killing a lot of people," pointing out that "missiles and drones are being shot into Cities in Ukraine, for no reason whatsoever." The US President warned that if Putin wants to conquer all of Ukraine, it will "lead to the downfall of Russia!" But Trump expressed frustration with Ukrainian President Volodymyr Zelenskyy as well, saying that he is "doing his Country no favours by talking the way he does."

Venezuelan voters skip election for lawmakers

Venezuelans still reeling from the outcome of last year's presidential election did not respond Sunday to government calls to get out and vote for lawmakers, governors and other officials. That left voting centres practically empty at times and put officials on the defensive. The election, which the political opposition urged people to boycott, was the first to allow broad voter participation since the presidential contest that President Nicolas Maduro claimed to have won last year despite credible evidence to the contrary. It took place two days after the government had ordered people, including a prominent opposition leader, to link them to an alleged plot to hinder the vote.

Members of the military throughout the day outnumbered voters at many polling centres in the capital, Caracas, where no lines formed outside in stark contrast with the enthusiasm of the July presidential election, when some people lined up for hours. But senior government officials insisted polling centres saw such overwhelming participation on Sunday that they had to remain open past the scheduled 12 hours of operation. Electoral authorities said 42.66 per cent of registered voters cast ballots across the country. Some 2.14 million people were registered, meaning the National Electoral Council claimed that about 9.12 million voters participated.

Romania's newly elected president sworn in

Romania's newly elected president Nicușor Dan was officially sworn in Monday, ushering in a tentative close to the worst political crisis to grip the European Union country in decades after the annulment of the previous election. But multiple challenges lie ahead.

George Simion, who had challenged the results at a top court, but was rejected last week. At the inauguration ceremony in a joint session of Parliament, Dan signed the constitution. In a speech afterwards, he promised to tackle Romania's economic woes and to be president "open to the voice of society."

The Romanian state needs a fundamental change... And I invite you to continue to be the social force you have proven, to put positive pressure on the institutions of the Romanian state so that they can reform," he said. "I assure you that I will be president who listens to the voice of society and who is a partner to that society." The May election redo was held months after the Constitutional Court voided the previous election in which the far-right outsider Calin Georgescu led a second round, following allegations of electoral violence and Russian interference, which Moscow has denied.

The court's unprecedented decision last year plunged Romania, which is a member of NATO as well as the EU, into a period of unprecedented political turmoil. The presidential role carries a five-year term and significant decision-making powers in national security and foreign policy. In the presidential election runoff, Dan ran independently as an "Honest Romania" ticket, reaffirming Western ties, continued support for Ukraine, and fiscal reforms. Addressing the economic challenges that lie ahead, Dan said Monday that "put simply... The Romanian state is in a state of emergency more than it is an effort." It is in the national interest for Romania to send a message of stability to financial markets," he said. "It is in the national interest to send a signal of openness and predictability to the investment environment."
