UK, France discuss Ukraine security

European countries are stuck between a rock and a hard place as a coalition of countries meets in Paris on Thursday to discuss security guarantees for a postwar Ukraine. The war is raging unabated, with no ceasefire in sight and the crucial question of American involvement in ensuring Ukraine's future security remains unresolved.

For months, the so-called "coalition of the willing" has been meeting to discuss aid for Ukraine, including sketching out plans for military support in the event of a ceasefire to deter future Russian aggression.

The coalition leaders — French President Emmanuel Macron and UK Prime Minister Keir Starmer — have insisted that any European "reassurance" force in Ukraine needs the backing of the United States. But while US President Donald Trump has hinted his country will be involved, he has moved away from calling for a ceasefire in Ukraine and refrained from implementing tough additional economic measures to punish Moscow.

Although Trump said he is "disappointed" in Russian President Vladimir Putin and issued several threats to try to cajole him into negotiating an end to hostilities, none have worked. At a meeting with Putin in Alaska in August, Trump failed

to persuade the Russian leader to stop fighting and has not yet managed to broker talks between Putin and Ukraine's President Volodymyr Zelenskyy.

While Trump and European leaders met in Washington after the Alaska summit, US, European and NATO military chiefs held discussions on support for Ukraine — little concrete detail has emerged on the security guarantees to deter Moscow from a future conflict. Former military generals and experts suggest Europe is in a bind — not

knowing the level of support the US is prepared to provide the coalition, the nature of any ceasefire or if the US will abide by commitments made. It's also far from certain that Putin would agree to a cessation of hostilities, something Russian officials have invariably dismissed.

"Talking about detailed operational planning when you don't actually have your mission is, quite frankly, impossible," said Ed Arnold, an expert in European Security at the Royal United Services Institute in London

and a former military planner. The "coalition of the willing" is a broad term for about 30 nations supporting Ukraine, but the so-called "reassurance force" that would provide security guarantees to Kyiv is a subset of that group.

The UK, France and Estonia have all suggested they are ready to deploy troops to Ukraine to deter Putin from attacking again, while officials in Poland said Warsaw will not take part and will instead focus on bolstering NATO security in the east of Europe. There is "no sug-

gestion" that any troops will be deployed without a ceasefire, he said.

Francis Heisbourg, special adviser at the Foundation for Strategic Research in Paris. Despite Zelenskyy signalling his willingness to talk, a ceasefire agreement is not currently in the cards — not least because of the positions of the US and Russian presidents. At his August 18 meeting with European leaders at the White House — Trump walked back his previous demands for a ceasefire in Ukraine and said

he thought a peace agreement was preferable. The comments marked a shift toward the Russian position from Trump and would allow Moscow to fight on in Ukraine while peace negotiations are underway.

Russian Foreign Minister Sergey Lavrov later suggested an end to hostilities was even further away, stating that Moscow will not accept Zelenskyy's signature on any peace agreement as Russia considers him to be an illegitimate president.

"If Putin doesn't want a ceasefire and if Trump doesn't call for a ceasefire — what are the chances of a ceasefire happening?" asked Heisbourg. Even if a ceasefire or peace agreement for Ukraine were implemented, it's not clear it would be sufficient deterrent to Putin and would be "very, very risky" for European nations, said Arnold at RUSI.

Such an operation hinges on the US providing intelligence support and the deterrent effect of US airpower in countries outside Ukraine.

The Western appetite to potentially shoot down Russian missiles violating a ceasefire or target launchers firing them from within Russia is "close to zero," said Heisbourg. Any response to a ceasefire violation, he said, would likely depend on "how many Western soldiers the Russians would have actually killed and nobody wants to think about that too much in advance."

Amit Kshatriya named NASA associate administrator

A decorated Indian-American Amit Kshatriya has been named as NASA's new "exploration-focused" associate administrator, the US space agency announced.

Kshatriya, a 28-year NASA veteran, was most recently the deputy in charge of the Moon to Mars Programme in the Exploration Systems Development Mission Directorate (ESDM) at the National Aeronautics and Space Administration (NASA) headquarters in Washington.

"Acting NASA Administrator Sean P. Duffy on Wednesday named exploration-focused Amit Kshatriya as the new associate administrator of NASA, the agency's top civil



service role," a NASA statement said. Born in Wisconsin to Indian immigrant parents, educated at California Institute of Technology (CalTech) and the University of Texas at Austin, Kshatriya is one of only about 100 people in history to serve as a mission control flight director. He joined NASA in 2003. Kshatriya was decorated with the NASA Outstanding

Leadership Medal for actions as the lead flight director for the 50th expedition to the space station, according to his profile on the NASA website. He is also the recipient of a Silver Snoopy, an award astronauts bestow for outstanding performance contributing to flight safety, for his actions as lead robotics officer for the Commercial

Orbital Transportation Services Dragon demonstration mission to the orbiting laboratory, it added. In his new role, he serves as the highest-ranking civil servant at the agency and as a senior advisor to Duffy, NASA said. Kshatriya leads the agency's 10 centre directors, as well as the mission directorate associate administrators at NASA headquarters in Washington.

He also acts as the agency's chief operating officer. Earlier in his role as the deputy in charge of the Moon to Mars Programme, Kshatriya was responsible for programme planning and implementation for crewed missions to the Moon through the Artemis campaign in preparation for humanity's first mission to Mars.

Israel President meets Pope

Pope Leo XIV met on Thursday with Israeli President Isaac Herzog, as Israel presses ahead with a planned offensive in Gaza and the Vatican urging an immediate ceasefire and return of hostages taken by Hamas.

Herzog's motorcade arrived at the Apostolic Palace and the president was escorted into the red-carpeted halls past a phalanx of Swiss Guards. Herzog's office said ahead of the meeting that talks were expected to focus on efforts to release hostages, fight antisemitism globally and safeguard Christian communities in the Middle East.

The statement said the visit to the Vatican came "at the invitation of the pope."

Vatican spokesman Matteo Brunetti disputed that, implying Herzog had requested the meeting. "It is the practice of the Holy See to grant requests for audiences addressed to the pope by heads of state and government; it is not the practice to extend invitations to them," Brunetti said in a statement Tuesday. Herzog's role as Israeli president is largely ceremonial. A former Labour party leader, he has called for unity and compromise

since taking office. Hamas took 251 hostages on October 7, 2023, in the attack that also killed about 1,200 people and triggered the war. Most hostages have been released during previous ceasefires or other deals. Israel has rescued eight hostages alive. Of the 50 still in Gaza, Israeli officials believe around 20 are still alive. The Vatican has tried to maintain its tradition of diplomatic neutrality throughout the war, calling

for the return of hostages while denouncing Israel's attacks against civilians in Gaza. Pope Francis' thoughts went further, labelling Israel's attacks in Gaza "immoral" and disproportionate and calling for an investigation to determine if they constituted genocide. Israel has denied the genocide charge, saying it only targets militants and takes measures to spare civilians. It blames civilian deaths on Hamas because the militants operate in densely populated areas. Leo, who was elected history's first American pope in May after Francis' death, has continued Francis' tough line.

He has called for the release of hostages but demanded Israel stop the "collective punishment" and forced displacement of Palestinians in Gaza.

Australia's ambassador exits Iran

Iran said on Thursday it has "downgraded" its relations with Australia in response to the expulsion last week of its ambassador over accusations that Tehran masterminded antisemitic arson attacks in Sydney and Melbourne.

The official IRNA news agency cited Iran's foreign ministry spokesman Mesut Baghaei as saying that Australia's ambassador has already left Iran, adding that Iran's consulate section is active in Australia and Iran will try to meet consular

needs of Iranians there. According to diplomatic norms and right in reaction to Australia attack, Iran has downgraded level of diplomatic presence of Australian in Iran. "Baghaei was quoted as saying.

He also rejected antisemitic accusation, the report said. He described Australia's decision last week to expel the Iranian ambassador as "unreasonable," adding: "We do not welcome lowering relations since there is no reason and justification for the move.

It affects relations between the two nations," Australian Prime Minister

Anthony Albanese cut off diplomatic relations with Iran after Australian intelligence officials said Iran had directed arson attacks on the L'Espresso restaurant in the Levantine Kitchen, a kosher food company, in Sydney, in October 2024 and on Melbourne's Adas Israel Synagogue two months later. Mike Burgess, the director-general of the Australian Organisation, said in a statement Tuesday.

Neither Burgess nor Albanese explained what evidence there was of Iranian involvement.

Fashion designer Armani dead at 91

Giorgio Armani, the Italian designer who turned the concept of understated elegance into a multibillion-dollar fashion empire, has died, his fashion house confirmed. He was 91. Armani died at home, the fashion house said.

Armani, one of the most recognisable names and faces in the global fashion industry, missed Milan Fashion Week in June 2025 for the first time during the previews of Spring-Summer 2026 menswear to recover from an undisclosed condition.

Portugal mourns Lisbon street car tragedy

Portugal observed a national day of mourning on Thursday, a day after a family Lisbon street car killed and injured 15 people in the capital's worst accident in recent history.

Authorities have given no information about the causes from three other police said were injured in

the accident, raising the initial casualty toll.

The 19th-century streetcar is one of Lisbon's big tourist attractions and is usually packed with foreigners at this time of year for its short and picturesque trip up and down one of the city's steep hills.

India-Singapore cement strategic partnership

India and Singapore have formally adopted a detailed and forward-looking roadmap to strengthen their Comprehensive Strategic Partnership (CSP), marking a significant milestone in bilateral relations as the two countries celebrate 60 years of diplomatic tie.

The announcement came during the official visit of Singapore Prime Minister Lawrence Wong to India from September 2 to 4, at the invitation of Indian Prime Minister Narendra Modi.

The two leaders held wide-ranging talks on September 4 in New Delhi and witnessed the exchange of multiple Memoranda of Understanding (MoUs). Prime Minister Wong also called on President Droupadi Murmu and paid tributes at Raj Ghat.

Both sides expressed satisfaction over the current state of relations and agreed to further deepen cooperation across eight key sectors, economic partnership, skills development, digitalisation, sustainability, connectivity, healthcare, people-to-people exchanges, and defence and security. The new roadmap builds upon the decision taken during Prime Minister Modi's 2022 visit to Singapore to elevate bilateral ties to the level of a Comprehensive Strategic Partnership.

The leaders emphasised that the CSP is designed to be forward-looking and action-oriented, with concrete goals and a clear vision for long-term collaboration. In the area of economic cooperation, the two countries aim to enhance bilateral trade and investment by building on the Comprehensive Economic Cooperation Agreement (CECA) and accelerating the review of the ASEAN-India Trade in Goods Agreement.

There is a particular focus on supporting India's growing semiconductor industry, through joint

research, policy dialogue, and investment facilitation. The countries also plan to collaborate in space technology, capital markets, and the development of sustainable industrial parks. In skills development, both sides agreed to establish a National Centre of Excellence in Chennai focusing on advanced manufacturing. They will also collaborate on technical education, vocational training, and workforce upskilling, including partnerships between Indian and Singaporean educational institutions.

In the area of cooperation, India and Singapore will work closely on fintech innovation, cyber security, artificial intelligence, and cross-border investments. The UPI+New Link will serve as a base for expanding digital connectivity between the two countries.

In sustainability, the focus areas include cooperation on green hydrogen, urban water management, and climate change mitigation under the Paris Agreement framework. The two sides also agreed to deepen food security cooperation, including export facilitation of key agricultural goods. Connectivity will be boosted with plans to create a Green and Digital Shipping Corridor linking Indian ports with Singapore.

The countries will also explore expanding their bilateral air services agreement and collaborate on sustainable aviation fuels and airport development. The healthcare cooperation includes collaboration on digital health, disease surveillance, medical research and training.
